4 Matters Arising from the Minutes

White gates with signage for entrance to village (Norfolk Road). The PC decided on sign dimensions h 545mm, w 1150mm, Clerk to obtain advice on contractor and STATS check. Purchase of 2 new litter bins and 3 additional dog bins. The bins have been delivered and will shortly be installed. Litter bins: bottom of the steps to playing field and near the tennis courts. Dog bins: bottom of the steps and 2 other entrances to the playing field, the new signs will be installed at the same time. The extra bins will cost £1 each per empty. A complaint has been made about dogs running loose and unattended on the field and allotments.

New boards around MUGA – Contractors waiting for better weather.

Update addresses on land registry certificate for land surrounding Community Centre. The solicitors will do this for free.

Cllr Farrands asked if anything more had been heard about hall hire charges, the PC has in the past paid a £50 flat fee for the year in exchange for a 50p per year lease to the WCC.
