PUBLIC FORUM -to include COUNTY & DISTRICT COUNCILLOR'S REPORTS.

C Councillor Dunning introduced herself and thanked the Council for inviting her, she has been contacted by a resident of the High St who is concerned that excess rain water from the A12 is draining into their garden. Cllr A Smith will attend a site meeting with Cllr Dunning as he knows the history surrounding the current problem. Chapel Road, Wrentham will be closed from the 21st July for drainage works. Covid cases are up in the ESC area with 247 cases reported this week. She has joined the Wangford Quarry Liaison Committee, Cllr Farrands is the PC's rep. Cllr Carter asked if Cllr Dunning could help with his campaign to reduce the speed limit on the A145 through Henham, the Clerk will send over old correspondence on the matter. Cllr A Smith asked if she would be able to take up where Cllr Goldson left off regarding funding for the changes to bus stops, Cllr S Smith to send over Previous correspondence. Cllr Dunning left the meeting.

Bus stops - See Public Forum

Prevention of vehicular access to playing field – No progress, materials needed are in short supply at the moment. The new gates will be sited to prevent free vehicle access to the allotments across the playing field, access will still be possible through the Community Centre's overspill car park.

New signs – In hand, Cllr A Smith is looking for stronger, more eco friendly signs than those used previously.

Tracker for Tractor – Waiting for quote from Ben Burgess, Clerk to ask insurance company if one will lower their quote.

Possible social media account for PC – In hand.

Clerk's report to include Police Report sourced from Suffolk Constabulary's Website. There were 3 crimes reported in May: 1 x public order – A12 junction, investigation complete no suspect identified. 2 x ASB, Old Priory Gdns.

Cllr Pepper: the book exchange is now up and running, lots of books have been donated. Cllr A Smith remarked that the old kiosk looks very good. 13 people made up the working party in the new garden area, thanks went to all the volunteers and to Cllrs Utting & Ives who provided refreshments and to Rachel for taking the orders. Due to social distancing regs there will working parties on the 1st Sunday of the month for a while. A pyramid orchid and a white bee orchid have been discovered since mowing stopped, these finds have been reported to the County Council recorder. Marion Welham, a journalist, is writing a piece with photographs on the allotments for The Suffolk Magazine out in August. There are 3 half plots vacant, Clerk to put up a notice.

Cllr Carter complained that no one from Festival Republic has attended any meetings to discuss their traffic plan for the Latitude Festival, he is expecting the usual traffic chaos. Cllr A Smith explained that he had invited them in previous years but Covid restrictions made this impossible even if they wanted to this year. Heavy traffic is, unfortunately, part and parcel of these types of events all over the country and Cllr Carter was urged to call the police if he observes any dangerous driving.
