PUBLIC FORUM -to include COUNTY & DISTRICT COUNCILLORS REPORTS

Carol Wood asked why the MUGA has now become known as the tennis court. It will remain as a MUGA but for the purposes of a lock entry system, it has been referred to as a tennis court. She also asked why the village gateway signs are not on the agenda. Quotes for the signs have been given and the PC are awaiting quotes for the installation of same. Once the quotes have been received, they will be back on the agenda. The PC was asked about weedkilling around the perimeter of the MUGA. This is in hand. Cllr. S Smith asked that a vote of thanks is given to Mrs. Marfleet who has single handedly weeded around the multi games area.

Cllr. Ashton reported that the Gull Wing bridge was in place and awaiting testing before being opened. He also reported on LionLink and would do as much as he could to oppose the plan. He is also dealing with a litter picking campaign "East Suffolk is Amazing" and would welcome any thoughts or ideas.

Bus Stops and route through village – update. Cllr. A. Smith had contacted County Cllr. A. Dunning again to see why there had been no further progress and received the following response." County have double checked with First and they are looking at April for changes to the 99 corridor. They have been delayed a bit while they have been adjusting to extra services coming into Suffolk funded by Norfolk CC with their BSIP grant, but they are now working out how the Suffolk services operated out of Lowestoft will fit in."

- CCTV update Cllr. S. Smith gave a demonstration to all attending to show how the CCTV cameras work and how they can record and store information up to a month so that it can be reviewed if any issues are reported
