PUBLIC FORUM - to include COUNTY & DISTRICT COUNCILLOR'S REPORTS.

Clir Brooks' monthly report had been circulated, things have been pretty quiet at the moment. ESC's diesel vehicles will be made to run on bio diesel and other vehicles will be replaced with electric ones over time. Plans have been passed to construct a new design of building in Beccles, which if satisfactory, will become the model for all new social housing in the district.

Cllr Dunning's parishes report to be circulated. Some casework around the village has been completed, a meeting will be held with Cllr A & S Smith regarding funding of the bus stops project. At the meeting of the Wangford Quarry Liaison Group the rep from Breedon said that the expansion at Kiln Farm will definitely not go ahead. Breedon may apply for another time extension for extraction, but told the meeting that the site will probably be exhausted withing 18 months, their restoration plan to be circulated. The Boundaries Commission have put in a draft for more changes in an effort to reduce County Councillor numbers. Cllr Dunning & Brooks left the meeting at 8.15pm.

Bus stops – Postponed meeting with C Cllr Dunning to be rearranged Prevention of vehicular access to playing field – still awaiting delivery of materials. New signs – Cllr S Smith unable to find any suitable ones. Tracker for Tractor – still awaiting fitting, Cllr S Smith to chase them up. Possible social media account for PC. Sally Smith quoted £50 per month to set up and run Facebook and Twitter accounts for the PC. Cllr Farrands proposed acceptance, 2nd Cllr Pepper, 8 for, 1 abstention. Clerk to liaise with Sally.

CIIr A Smith has received a complaint via email that the cycle path alongside the A12 between Frostenden & Wangford is very overgrown, Clerk has reported it to Norse. Cllr Smith will meet with Barry Dewing re cutting back overgrowth on path from the Vets to the shop. He will contact Melvin Benn (Festival Republic) again for a donation to the wild flower garden. Mr Benn was keen on the idea before lockdown affected finances. **Clir Miller** WCC have been decorating the committee room and do not want to rehang the pictures they say belong to the PC, they will be placed in PC's part of the storeroom.

Clir Pepper the grass on the wild flower garden has been cut, raked and disposed of, he would like to buy some more bulbs and wildflower seeds – the cost can come from Latitude ticket sales money. He thanked all the volunteers that have helped out over the year. The book swap is going well. There was a very nice piece in the Suffolk Magazine about the allotments which some people have given up this year. It was agreed that a skip should be ordered in October to dispose of accumulated rubbish around the allotments. **Clir Utting** has asked ESC to repair the post and rail fence in Millfields.
